**Notification on Holding the Hearing
Concerning the Anti-dumping Case of Pork and Pig By-products**

All Interested Parties:

On 17 June 2024, the Ministry of Commerce of the People's Republic of China issued an announcement initiating an anti-dumping investigation into pork and pork by-products imported from the European Union.

Following applications from the European Commission and the French Pork Industry Association, and to ensure the fairness, impartiality, and transparency of the investigation process, in accordance with Article 20 of the Anti-Dumping Regulations of the People's Republic of China and the Rules for Hearings in Anti-Dumping and Countervailing Investigations of the Ministry of Commerce, the Trade Remedy and Investigation Bureau of the Ministry of Commerce has decided to hold a hearing on the anti-dumping case involving certain pork and pork by-products at the Ministry of Commerce in the near future. Relevant details are notified as follows:

1. The hearing will address matters related to dumping, injury, and the causal relationship between the two in the preliminary determination of this case.
2. Interested parties applying to participate in the hearing must complete the Registration Form for Participation in the Hearing on the Anti-Dumping Case Regarding Certain Pork and Pork By-Products (see attachment) and submit it via the "Trade Remedy Investigation Information Platform" by 17:00 on Thursday, 23 October 2025. If an interested party fails to submit the application within the time limit specified in this notice, the Ministry of Commerce reserves the right to deny their participation in the hearing and refuse to accept any related materials submitted.
3. Interested parties applying to speak at the hearing must, alongside the aforementioned registration form, submit a written summary of their intended remarks and relevant evidence materials. The designated language and text for the hearing are Chinese.
4. The speaking time for representatives participating in the hearing will be determined by the Ministry of Commerce based on registration details.
5. This notice and the registration form are published on the Trade Remedy and Investigation Bureau subsite of the Ministry of Commerce website (<http://trb.mofcom.gov.cn>) . Interested parties may download them directly.
