The European Commission is launching a Call for expressions of interest aimed at EU companies with an economic interest in working in North Africa and the Middle East countries. The key targeted areas are sectors aligned with the strategic priorities of the **Pact of the Mediterranean** ([https://north-africa-middle-east-gulf.ec.europa.eu/what-we-do/pact-mediterranean\\_en](https://north-africa-middle-east-gulf.ec.europa.eu/what-we-do/pact-mediterranean_en)) and the **Global Gateway** ([https://north-africa-middle-east-gulf.ec.europa.eu/what-we-do/global-gateway-mediterranean\\_en](https://north-africa-middle-east-gulf.ec.europa.eu/what-we-do/global-gateway-mediterranean_en)), but it will also collect other relevant information.

The Call aims to gather market intelligence from the EU private sector as well as to identify potential areas for EU support and collaboration.
